

Candidates are required to produce following original documents for verification:-

1. Secondary Mark-Sheet or Certificate issued by Board of Secondary Education or Institution established by Law in India or equivalent examination from any Institute recognized by the Government which contains date of birth.
2. Mark-Sheet or Degree or Certificate with regard to Graduation Examination issued by any University established by Law in India or equivalent examination from any University recognized by the Government for the purpose.
3. Caste Certificate claiming benefits of reservation i.e. Scheduled Caste or Scheduled Tribe or Other Backwards in accordance with orders/guidelines issued by the State Government for the purpose.
4. Divorcee Women claiming benefit of that account will have to submit decree of Court of Law in India and Widow Women shall have to submit the death certificate of her deceased husband issued by Competent Authority.
5. Last institution character certificate issued by Principal/Academic Officer of the University, College or School.

6. Two Character Certificates issued by the responsible person (separately) not connected with University, College or School and not related to him which is not more than six months old prior to the date of final result of recruitment.
7. Certificate or affidavit whether convicted or not from any Court of Law in India.
8. Candidate who has claimed reservation under Outstanding Sports Persons shall have to submit Certificate with regard to participation individually or in Team in the Sports and Games recognized by the International Olympic Committee and Indian Olympic Association or Association/Federation recognized by their respective National Level Association or Federation or Board in which he/she or team obtained 1st, 2nd or 3rd position.
9. Candidates who have claimed reservation under the quota of Physically Handicapped persons shall have to submit required certificate issued by the Competent Authority.
10. Candidate who has applied for the post for claiming age relaxation being a Government Employee will have to submit No objection Certificate with initial appointment order under which he/she was appointed in the State Government.
11. Those Candidates who have claimed age relaxation being reservist of defence services shall have to submit proof thereof.
12. Candidate shall have to submit marriage certificate or affidavit in support of their marital status with number of children supported by necessary proof.
13. Attested copies of all relevant documents.
14. Proof of identification viz. Driving Licence, Aadhar Card, Passport, Voter Card etc.
