Revised Notice

In compliance of directions of Hon'ble Chairman, Rajasthan High Court Legal Services Committee, Jaipur and in exercise of powers conferred under regulation, 1999 of the Rajasthan State Legal Services Authority, it is proposed to prepare separate panel of maximum 25 lawyers each for (1) Civil Matters (2) Criminal Matters (3) Constitutional Law / Writ matters (other than service cases) (4) Environmental Law (5) Labour Law and service matters (6) Matrimonial disputes (7) Matters before the Central Administrative Tribunal/ Armed Forces Tribunal, to represent and plead the cases on behalf of the persons provided with legal aid under these regulations by the committee. Applications are therefore invited from the advocates with their bio-data, who fulfill the following revised criteria:-

1. He/She should possess experience of at least five years at the Bar on the last date of receipt of the application;
2. He/She should furnish copy of 'Sanad'/copy of certificate of registration with the Bar Council of Rajasthan.
3. He/She should be a regular practitioner of law before the Hon'ble Rajasthan High Court and member of the High Court Bar Association for last three years.
4. **That he/she shall furnish copies/details of the judgments of at least five such cases independently argued by him/her and decided on merits, of the category in which he/she has applied for empanelment.**
5. He/She shall furnish an undertaking to the effect that he/she willing to work as panel lawyer and shall not ask for or receive any fee/remuneration in any manner from the person for whom he/she has been engaged to provide legal aid services,
6. He/She shall make himself/herself available to deal with the legal aid cases and shall not appear against the party to whom legal aid has been provided.

Note- Applicants who have already applied as per previous notice need not to apply again.

Applications along with necessary documents should be submitted in the office of the undersigned dated by 5 P.M. of 15th January, 2017.
